THE CLINIC STAFF IS MADE UP OF ONE PAID PHYSICIAN, OVER 90 VOLUNTEERS INCLUDING SIX ADDITIONAL DOCTORS, REGISTERED NURSES AND ADMINISTRATIVE HELP.
